Dear Sir,

I, CS Hardik Hudda (Membership No: A39621, CP No: 14697), Proprietor, M/s. Hardik Hudda & Associates, Company Secretaries, was appointed as Scrutinizer to scrutinize the process of e-voting and postal ballot of your company i.e. **Atul Auto Limited (CIN: L54100GJ1986PLC016999)** under the provisions of the Act read the Rules (as amended from time to time) and pursuant to Listing Regulations read with General Circular no. 14/2020 dated April 08, 2020, circular No. 17/2020 dated April 13, 2020, circular No. 22/2020 dated June 15, 2020, circular No. 33/2020 dated September 28, 2020, circular No. 39/2020 dated December 31, 2020, circular No. 10/2021 dated June 23, 2021, circular No. 20/2021 dated December 8, 2021, circular No. 03/2022 dated May 05, 2022 and circular No. 11/2022 dated December 28, 2022 and other relevant circulars issued by the Ministry of Corporate Affairs, Government of India (collectively referred to as "MCA Circulars") for the purpose of scrutinizing remote e-voting for postal ballot process in a fair and transparent manner and ascertaining the requisite majority for the said voting as per the provisions of the Act and the Rules, as amended, on the resolutions referred to in this report.

My responsibility as a Scrutinizer for the Postal Ballot through Remote E-voting process, is restricted to the preparation of the Scrutinizer's Report of the votes cast "in favor" and/or "against" the resolution stated in the Postal Ballot notice dated March 06, 2023, based on the report generated from the e-voting system provided by National Securities Depository Limited (NSDL), the Authorized agency engaged by the Company to provide remote e-voting facilities.



I submit my report as under:

1. The Postal Ballot Notice dated March 06, 2023 along with necessary statements setting out the material facts under Section 102 of the Companies Act, 2013 were sent on March 22, 2023 by the Company through electronic mail to those members whose names appeared in the Register of Members/ List of Beneficiaries as on March 17, 2023 ("cut-off date") and who had registered their email ID with the Company/ RTA/ Depositories in compliance with the MCA Circulars.
2. The shareholders of the Company holding shares as on the "Cut-off" date (i.e. on Friday, March 17, 2023) were entitled to vote on the resolutions as set out in the Notice of Postal Ballot.
3. The Company has published on March 24, 2023 an advertisement about the dispatch of the Postal ballot Notice.
4. I have monitored the process of electronic voting through the scrutinizer's secured link provided to me (<https://www.evoting.nsdl.com/>).
5. The remote e-voting period for the postal ballot commenced on Friday, March 24, 2023 at 09:00 a.m. (IST) and ended on Saturday, April 22, 2023 at 05:00 p.m. (IST). During this period shareholders of the Company, holding shares, as on the cut-off date i.e. Friday, March 17, 2023 cast their vote electronically.
6. After the closure of remote e-voting, I have unblocked the votes cast in the presence of two witnesses who are not in the employment of the Company.
