- The Postal Ballot Notice dated March 06, 2023 along with necessary statements setting out the material facts under Section 102 of the Companies Act, 2013 were sent on March 22, 2023 by the Company through electronic mail to those members whose names appeared in the Register of Members/ List of Beneficiaries as on March 17, 2023 ("cut-off date") and who had registered their email ID with the Company/ RTA/ Depositories in compliance with the MCA Circulars.
